

Privacy Policy

Car Haul Direct will not share or sell any of your contact information to any third parties for any reason. All information collected is used solely for the purpose of giving you free quotes for transporting your vehicle.

This notice describes our privacy policy.

The information we learn from customers helps us personalize and continually improve your shopping experience at Car Haul Direct. Here are the types of information we gather.

We receive and store any information you enter on our Web site or give us in any other way. You can choose not to provide certain information, but then you might not be able to take advantage of many of our features. We use the information that you provide for such purposes as responding to your requests, customizing future needs, improving our services, and communicating with you.

Automatic Information: We receive and store certain types of information whenever you interact with us. For example, like many Web sites, we use "cookies," and we obtain certain types of information when your Web browser accesses Car Haul Direct website.

E-mail Communications: To help us make e-mails more useful and interesting, we often receive a confirmation when you open e-mail from Car Haul Direct if your computer supports such capabilities. We also compare our customer list to lists received from other companies, in an effort to avoid sending unnecessary messages to our customers. If you do not want to receive e-mail or other mail from us you may opt-out .

We share customer information only as described below and with subsidiaries also subject to this Privacy Policy.

We work closely with our affiliated businesses. In most cases, we provide services, or make recommendations for product and services with these businesses. See below for some examples of co-branded and joint offerings.

Promotional Offers: Sometimes we send offers to selected groups of Car Haul Direct customers on behalf of other businesses. When we do this, we do not give that business your name and address. If you do not want to receive such offers you can opt not to receive them.

Car Haul Direct will release account and other personal information when compliance with the law requires; or in order to protect the rights, property, or safety of Car Haul Direct, our customers, or others. This includes exchanging information with other companies and organizations for fraud protection and credit risk reduction. This does not include selling, renting, sharing, or otherwise disclosing personally identifiable information from customers for commercial purposes in violation of the commitments set forth in this Privacy Policy.

We work to protect the security of your information during transmission by using Secure Sockets Layer (SSL) software, which encrypts information you input.

We reveal only the last five digits of your credit card numbers when confirming an order.

If you do not want to receive e-mail or other mail from us, please send us an opt-out notification. (If you do not want to receive this Privacy Policy, or other legal notices, those notices will still govern your use of Car Haul Direct, and it is your responsibility to review them for changes.)

Car Haul Direct does not sell services for purchase by children. If you are under 18, you may use Car Haul Direct services only with the involvement of a parent or guardian.

Conditions of Use, Notices, and Revisions

If you choose to visit Car Haul Direct website, your visit and any dispute over privacy is subject to this Policy, including limitations on damages, arbitration of disputes, and application of the law of the state of Texas. If you have any concern about privacy at Car Haul Direct, please contact us with a thorough description of your concern, and we will try to resolve it.

Our business and internet procedures and services evolve constantly and our Privacy Notice will change also. We may e-mail periodic reminders of our notices and conditions, unless you have instructed us not to, but you should check our Web site frequently to see recent changes. Unless stated otherwise, our current Privacy Notice applies to all information that we have about you and your account.

You provide most such information when you request a quote, participate in a survey, or communicate with our customer

service or sales departments.

Automatic Information

Examples of the information we collect and analyze include the Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information such as browser type and version, operating system, and platform; order history, the full Uniform Resource Locator (URL) clickstream to, through, and from our Web site, including date and time; cookie number; pages you viewed or information you requested and the phone number you used to call our 800 number. During some visits we may use software tools such as JavaScript to measure and collect session information, including page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page.

Information from Other Sources

Examples of information we receive from other sources include updated delivery and address information from our carriers or other third parties, which we use to correct our records and communicate more easily; account information, order history, information requests and page-view information from some partners of Car Haul Direct ; search term and search result information from some searches conducted through the Web; search results and links, including paid listings (such as Sponsored Links from Google); and credit history information from credit bureaus, which we use to help prevent and detect fraud and to offer certain credit or financial services to some customers.
